Pursuant to the provisions of Section 91 of the Companies Act, 2013 read with Rule 10 of the Companies (Management and Administration) Rules, 2014, as amended and Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Register of Members and Share Transfer Books of the Company shall remain closed from **Saturday, the 14th September, 2019 to Friday, the 20th September, 2019 (both days inclusive)** for the purpose of AGM.

In compliance with the provisions of Section 108 of the Companies Act, 2013, Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing to its Members holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. Friday, 13th September, 2019, the facility to exercise their right to vote by electronic means through remote e-voting facility provided by National Securities Depository Limited ("NSDL"). The procedure and instructions for remote e-voting has been given under Note No. 14 of the Notice.

In this regard, the Members are requested to note the following:

1. The remote e-voting period shall commence on, **Tuesday, the 17th September, 2019 from 9.00 A.M.** and ends on **Thursday, the 19th September, 2019 at 5.00 P.M.** The remote e-voting shall be disabled by NSDL beyond the said date and time.
2. The **cut-off date** for determining the eligibility to vote by electronic means or through Polling Paper at AGM is **Friday, the 13th September, 2019.**
3. The members who have cast their vote by remote e-voting prior to the AGM can also attend the AGM but shall not be entitled to cast their vote again.
4. Any person who becomes member of the Company after dispatch of the Notice of the AGM and holding shares as of the cut-off date i.e. Friday, the 13th September, 2019, may obtain the Login ID/User ID and password by sending a request at evoting@nsdl.co.in or to RTA at jksingla@alankit.com. However if a member is already registered with NSDL for Remote E-voting, such member can use his/her existing User ID and password for casting the vote through Remote E-voting.
5. A person, whose name is recorded in the Register of Members or in the Record of Beneficial owners as maintained by the depositories as on the cut-off date shall only be entitled to avail the facility of remote e-voting or voting at the AGM through polling paper.
6. Voting rights (for voting through remote e-voting as well as polling paper at AGM) shall be reckoned in proportion to his/her share in the paid up Equity Capital of the Company.

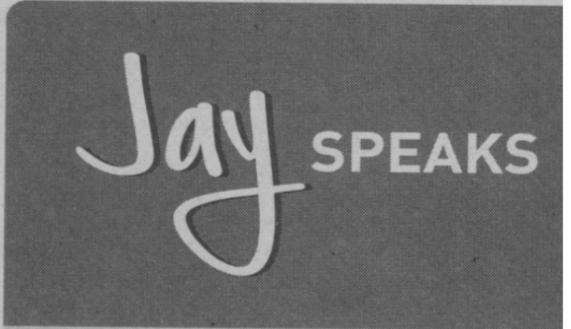
